On March 10, 2014, the Wisconsin Board of Nursing ("Board") issued an Order For Original Limited License ("Order") granting Applicant a limited professional nursing license (#143136-30) and suspending it indefinitely. Applicant has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On August 13, 2020, the Board considered Applicant's request for access to controlled substances and a reduction in the frequency of drug and alcohol screens. Based upon the information of record, the following is entered:

ORDER

- 1. Applicant's request for access to controlled substances is hereby GRANTED.
- 2. Applicant's request for a reduction in the frequency of drug and alcohol screens is hereby DENIED for insufficient time under the Order to demonstrate adequate compliance.
