On March 13, 2014, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On February 13, 2020, the Board considered Respondent's request for access to controlled substances, termination/modification of direct supervision and reduction in screens. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for access to controlled substances is hereby GRANTED.
2. Respondent's request for termination/modification of direct supervision and a reduction in screens is hereby DENIED. Respondent needs to show continuous successful compliance with the Order (03/13/2014).
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
