On December 14, 2014, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On January 9, 2020, the Board considered Respondent's request for a access to controlled substances and reduction in the frequency drug screens. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for access to controlled substances is hereby GRANTED.
2. Respondent's request for a reduction in the frequency of drug screens is hereby DENIED. Respondent needs to practice nursing under the conditions of the modified Board order granting access to controlled substances before the Board will consider amending other requirements.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
