On February 12, 2015, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On February 13, 2020, the Board considered Respondent's request for the return of full, unrestricted licensure. Based upon the information of record, the following is entered:

ORDER

1. Respondent's request for the return of her professional nursing license (#138058-30) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
