On July 20, 2015, the Wisconsin Physical Therapy Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's five year right to renew. Respondent has been granted a stay of suspension on his five year right to renew and his physical therapist license (#9916-24) is currently limited with certain terms and conditions, including participation in a drug monitoring program.

The Board designee considered Respondent's request for a reduction in the frequency of drug screens. Based upon the information of record, the following is entered:

ORDER

1. Respondent's request for a reduction in drug screens is hereby GRANTED. Respondent's frequency is reduced to not less than 28 per year and one annual hair test.
2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
3. This order is effective the date of its signing.
