On June 29, 2016, the Wisconsin Board of Nursing ("Board") issued an Order granting limited license ("Order") limiting applicants' s professional nursing license for an indefinite period.

On June 11, 2020, the Board considered Applicant's request for a reduction in the frequency of drug and alcohol screens and termination of the AA/NA meeting requirement. Based upon the information of record, the Board finds and makes the following:

### **ORDER**

- Applicant's request for a reduction in drug and alcohol screens is hereby GRANTED. Applicant's frequency is reduced to not less than 28 urine screens per year and 1 annual hair test.
- Applicant's request for termination of the AA/NA meeting requirement is hereby DENIED due to insufficient time under the Board Order (6/29/2016) to demonstrate adequate compliance.
- Applicant was GRANTED a reduction in weekly AA/NA meetings. Applicant is 3. now required to attend not less than 1 AA/NA meeting per week.
- All other terms and conditions of the Order not otherwise modified remain in full 4. force and effect.
