On July 27, 2016, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board issued a Final Decision and Order ("Order") suspending Respondent's advanced practice social worker certificate and clinical social worker license for thirty (30) days. Respondent was also required to complete eight (8) hours of education in approved topics within ninety (90) days. On July 24, 2019, Respondent's credentials were suspended for failure to complete the education as ordered.

Based upon the information of record, which includes proof that Respondent has now completed the education, the following is entered:

ORDER

1. The suspension is terminated and Respondent's clinical social worker license (#8422-123) and advanced practice social worker certificate (#128511-121) are hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credentials are removed.
3. This order is effective the date of its signing.
