On August 5, 2016, the Wisconsin Department of Safety and Professional Services issued a Final Decision and Order ("Order") suspending Respondent's clinical substance abuse counselor and intermediate clinical supervisor credentials for thirty (30) days. Respondent was also required to complete eight (8) hours of education in approved topics within ninety (90) days. On July 24, 2019, Respondent's credentials were suspended for failure to complete the education as ordered.

Based upon the information of record, which includes proof that Respondent has now completed the education, the following is entered:

## <u>ORDER</u>

1. The suspension is terminated and Respondent's clinical substance abuse counselor (#15379-132) and intermediate clinical supervisor (#15383-134) credentials are hereby returned to full, unrestricted status.

2. All limitations and encumbrances upon Respondent's credential are removed.
