On February 13, 2017, the Wisconsin Professional Counselor Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board ("Section") issued a Final Decision and Order ("Order") suspending Respondent's professional counselor-in-training license for six months retroactive to October 1, 2016. Respondent's license was also limited with certain terms and conditions.

Respondent has submitted a request for removal of the limitations and the return of her license to full, unrestricted status. Based upon the information of record, the following is entered:

ORDER

1. Respondent's request for the return of her professional counselor-in-training license (#3227-226) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
