On May 3, 2017, the Wisconsin Dentistry Examining Board (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s dentistry license with certain terms and conditions, including participation in a drug monitoring program.

On September 1, 2020, the Board Liaison considered Respondent’s request for a reduction in the frequency of drug screens, reduction in AA/NA meetings, termination of direct supervision, termination of employer written acknowledgement of reviewing the Order and termination of work reports only if Respondent is working in a private practice setting. . Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent’s request for a reduction in drug screens is hereby GRANTED. Respondent’s frequency is reduced to not less than 36 per year.
 2. Respondent’s request for a reduction in AA/NA meetings is hereby GRANTED. Respondent is now required to attend not less than 1 AA/NA meeting per week.
 3. Respondents request for termination of direct supervision is hereby GRANTED.
 4. Respondents’ request for termination of written acknowledgement employer has seen a copy of his Order is hereby GRANTED.
 5. Respondent’s request for termination of quarterly work reports if working in a private practice setting is here GRANTED.
2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
 3. This order is effective the date of its signing.
