
On May 23, 2017, the Wisconsin Real Estate Appraisers Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's licensed appraiser credential. Respondent was required to complete sixty (60) hours of education in approved topics pursuant to the terms of the Order.
