On March 15, 2018, the Wisconsin Medical Examining Board (“Board”) issued a Final Decision and Order (“Order”) granting renewal of Respondent’s license to practice medicine and surgery limited with certain terms and conditions.

On December 16, 2020, the Board considered Respondent’s request for removal of the limitations and the return of his license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

2. All limitations and encumbrances upon Respondent’s credential are hereby removed.
