On January 16, 2019, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice medicine and surgery (#31872-20) for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

On June 17, 2020, Wisconsin Medical Examining Board ("Board") considered Respondent's request to surrender his license to practice medicine and surgery. Based upon the information of record, the following is entered:

ORDER

1. The permanent surrender of Respondent's Wisconsin license to practice medicine and surgery (#31872-20) and any appurtenant right to renew that license is hereby accepted.
2. In the event Respondent petitions the Wisconsin Medical Examining Board for relicensure to practice medicine and surgery in the future, the Board may enter an order denying such application without further notice or hearing. Whether to grant a license and whether to impose any limitations or restrictions on any license granted shall be in the discretion of the Board.
3. This order is effective June 17, 2020.
