On May 9, 2019, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license (#191651-30) with certain terms and conditions including the submission of quarterly work reports. The Order further states that if a report indicates poor performance, the Board may institute appropriate corrective limitations.

On June 11, 2020, the Board reviewed Respondent's work report. Based on the information of record, the following is entered:

ORDER

1. Respondent's professional nursing license (#191651-30) is further LIMITED as follows:

a. Respondent shall undergo one (1) hair test within 30 days of the date of this order.

b. Respondent shall complete an AODA assessment and fitness-to-practice assessment with providers pre-approved by the Board or its designee within 60 days of the date of this Order. Pending further Board action, Respondent shall work only in settings under direct supervision, both to be pre-approved by the Board or its designee.
