On July 10, 2019, the Dentistry Examining Board (Board) issued its Final Decision and Order in the above-captioned matter by which the Board ordered that pursuant to Wis. Stat. § 440,22, the costs of this proceeding be assessed against Respondent. The Board received the Affidavits of Costs from the Division of Legal Services and Compliance and Division of Hearings and Appeals. The Board considered the Affidavits of Costs on May 6, 2020, and orders as follows:

ORDER

Pursuant to Wis. Stat. § 440.22, the costs of this proceeding in the amount of \$4,371.33 are assessed against Respondent and shall be payable by Respondent to the Department of Safety and Professional Services (Department). Failure of Respondent to make payment 120 days from the date of this Order, shall constitute a violation of the July 10, 2019 Final Decision and Order unless Respondent petitions for and the Board grants a different deadline. Under Wis. Stat. § 440.22(3), the Department may not restore, renew or otherwise issue any credential to Respondent until Respondent has made payment to the Department in the full amount assessed.
