On September 17, 2019, the Wisconsin Board of Nursing (Board) issued a Final Decision and Order (Order) reprimanding Respondent's professional nursing license, and further limiting her license with certain terms and conditions including, but not limited to, completion of a Fitness to Practice Evaluation by a pre-approved psychiatrist or psychologist and completion of an Alcohol and Other Drug Abuse (AODA) assessment by an evaluator pre-approved by the Board. The Board, or its designee, may impose additional limitations upon Respondent's license based on the results of the assessments and/or the evaluator's recommendations.

On December 12, 2019, the Board reviewed the Fitness to Practice Evaluation from the encounter date October 31, 2019 and the AODA assessment from encounter date October 2, 2019 (AODA assessment). Based upon the information of record, the Fitness to Practice evaluation, the AODA assessment, and the evaluator's recommendations, the Board finds and makes the following:

ORDER

1. Respondent's Professional Nursing License (#147524-30) is further LIMITED as follows:
  - a. Respondent shall work only under direct supervision, and only in a work setting pre-approved by the Board. Respondent shall only work in non-clinical settings.
