On September 17, 2019, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license (#107683-30) with certain terms and conditions including, but not limited to, completion of an evaluation by an approved mental health provider experienced in evaluating health care practitioners' fitness to practice. The Order further states that the Board or its designee may limit Respondent's license in a manner to address any concerns as a result of the conduct set out in the findings and fact and any recommendations resulting from the evaluation.

1. Respondent's professional nursing license (#107683-30) is further LIMITED for a period of at least two (2) years as follows:

a. Respondent shall provide all nursing employers with a copy of her Board Order(s).

b. Respondent shall work under general supervision and arrange for nursing employer to send quarterly reports to the Department Monitor.

c. Respondent shall continue therapy recommended by treater.
