On September 18, 2019, the Wisconsin Board of Nursing issued an Order Granting Limited License ("Order"), which granted Applicant a limited professional nurse license with certain terms and conditions. Pursuant to the Order, Applicant's license may be suspended, without further notice or hearing, for violation of any provision.

Information has been received that demonstrates Applicant has failed to comply with all requirements for participation in drug and alcohol monitoring established by the approved drug monitoring program and therefore is in violation of the terms of the Order. As a result, the following is entered:

1. Applicant's professional nurse license (#178646-30) is hereby SUSPENDED until further notice.
