On October 15, 2019, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete four (4) hours of education in "dual relationships" and two (2) hours of education in "ethics" within ninety (90) days and pay \$414.00 in costs of the proceeding within ninety (90) days. On April 28, 2020, Respondent's social worker certificate was suspended for failure to complete the education and pay the costs of the proceeding as ordered.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

#### **ORDER**

- 1. The suspension is terminated and Respondent's social worker certificate (#12236-120) is hereby returned to full, unrestricted status.
  - 2. All limitations and encumbrances upon Respondent's credential are removed.
  - 3. This order is effective the date of its signing.
