On October 15, 2019, the Wisconsin Marriage and Family Therapist Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board ("Section") issued a Final Decision and Order ("Order") limiting Respondent's marriage and family therapist license. Respondent was required to comply with all of the requirements of the Final Decision and Order entered in the Division of Legal Services and Compliance Case #17 SOC 042 ("Order #0006483").

1. Respondent's marriage and family therapist license (#301-124) is returned to full, unrestricted status.
