On October 29, 2019, the Wisconsin Board of Nursing ("Board") issued an Order Granting Limited License ("Order") limiting Applicant's practical nursing license (#320892-31) with certain terms and conditions including, but not limited to, completion of an evaluation by an approved mental health provider experienced in evaluating health care practitioners' fitness to practice. The Order further states that the Board or its designee may limit Applicant's license in a manner to address any concerns as a result of the conduct set out in the findings and fact and any recommendations resulting from the evaluation.

On May 14, 2020, the Board reviewed and accepted the report resulting from Applicant's fitness to practice evaluation. Based on the evaluator's recommendations, the following is entered:

ORDER

1. Applicant's practical nursing license (#320892-31) is further LIMITED as follows:
  - a. Applicant shall continue psychotherapy as recommended in the fitness to practice evaluation and arrange for treater to submit quarterly reports.
