On November 14, 2019, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s professional nursing license (#150156-30) with certain terms and conditions including, but not limited to, completion of an alcohol and other drug abuse evaluation with a pre-approved evaluator experienced in whether a health care professional has alcohol or drug abuse issues. The Order further states that the Board or its designee may impose additional limitations upon Respondent’s license based on the results of the evaluation and/or the evaluator’s recommendations.

On May 14, 2020, the Board reviewed and accepted the report resulting from Respondent’s AODA evaluation. Based on the evaluator’s recommendations, the following is entered:

ORDER

1. Respondent’s professional nursing license (#150156-30) is further LIMITED as follows:

a. Respondent shall participate in treatment by a Board approved substance use disorder treatment provider and a psychiatrist as recommended in the AODA assessment.
