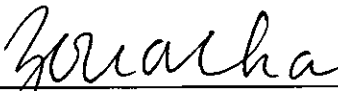
On December 12, 2019, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license. Respondent was required to complete five (5) hours of education on the topic of HIPAA pursuant to the terms of the Order.
