On August 5, 2020, the Wisconsin Board of Nursing ("Board") issued an Amended Final Decision and Order ("Order") suspending Respondent's practical nursing license for an indefinite period. Respondent may petition for a stay of suspension upon sufficiently establishing compliance with Sections C and D of the Order for a period of at least thirty (30) consecutive days.

Respondent's petition for an initial stay of suspension has been reviewed pursuant to the Order. Based upon the information of record, which demonstrates that Respondent qualifies for a stay of suspension at this time, the following is entered:

ORDER

1. The suspension of Respondent's practical nursing license (#314949-31) is hereby STAYED.
2. The stay is continuous, contingent upon Respondent's compliance with the terms and conditions of the Order.
3. This order is effective the date of its signing.
