On April 9, 2020, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s advance practice nurse prescriber license (#1332-33) and professional nursing license (#89144-30). Respondent was required to complete 4 hours of education in medication errors pursuant to the terms of the Order.

Respondent has submitted proof that she successfully completed the required education and as a result the following is entered:
