
On April 14, 2020, the Wisconsin Professional Counseling Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board ("Section") issued a Final Decision and Order ("Order") limiting Respondent's professional counselor and professional counselor-in-training licenses (#7070-125 and #3128-226). Respondent was required to complete four (4) hours of education on the topic of mandated reporting pursuant to the terms of the Order.

1. Respondent's professional counselor and professional counselor-in-training licenses (#7070-125 and #3128-226) are returned to full, unrestricted status.
