On May 6, 2020, the Wisconsin Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's dentistry license. Respondent was required to complete (8) hours of education in risk management, (40) hours in the topic of diagnosis, treatment and record keeping and (40) hours in the topic of correct planning, placement and record keeping of implants, pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

1. Respondent's dentistry license (#3916-15) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
