You are hereby notified that you are subject to a forfeiture of \$300.00 in accordance with Wis. Stat. § 101.66 because you engaged in dwelling contractor work without pulling the necessary permits as required by Wisconsin Code. This forfeiture must be paid within 30 days of the date of mailing of this Notice, or a 12% interest penalty will be assessed and/or enforcement action may be taken against you.

The forfeiture of \$300.00 shall be made out to the "Department of Safety and Professional Services." Include in the memo line "18 COM 164" and send to the following address:

You are receiving this forfeiture because you performed dwelling contractor work at 111 Putnam Street, Oakfield WI without obtaining a permit from the City of Oakfield. An investigation was opened and it was determined that work was done at the site in July 2018 and that you never pulled a permit for the work performed. Wis. Admin. Code Sec. SPS 305.31(4)(b) and 320.08 require that a permit be obtained prior to construction work being performed. An investigation by the Department found that you started construction on the deck without

obtaining a proper permit. As a dwelling contractor, you are required to confirm that a permit was obtained for construction work. Wis. Stat. Sec. 101.66 states that the Department may issue a forfeiture of not less than \$25 nor more than \$500 to any person who violates a rule promulgated by the Department.

For these reasons the forfeiture of \$300.00 is assessed in accordance with Wis. Stat. § 101.66.
