On July 9, 2020, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s professional nursing license (#139824-30) and advanced practice nurse prescriber certificate (#2508-33). Respondent was required to complete three (3) hours of education on the topic of professional accountability and legal liability, and three (3) hours on ethics, pursuant to the terms of the Order.

Respondent has submitted proof that she successfully completed the required education and as a result, the following is entered:

ORDER

1. Respondent’s professional nursing license (#139824-30) and advanced practice nurse prescriber certificate (#2508-33) are returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credentials are removed.
3. This order is effective the date of its signing.
