On August 13, 2020, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s professional nursing and advanced practice nurse prescriber licenses. Respondent was required to complete 17 hours of approved education topics pursuant to the terms of the Order.
