The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Pharmacy Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Respondent Stacey L. McDonald, R.Ph., (DOB: XX/XX/1986) is licensed in the state of Wisconsin to practice pharmacy, having license number 16488-40, first issued on August 1, 2011, and current through May 31, 2020. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is located in DePere, Wisconsin 54115.

2. At all times relevant to this proceeding, Respondent was employed as a managing pharmacist at a Pharmacy (Pharmacy), located in DePere, Wisconsin.

3. Respondent is the pharmacy manager at the Pharmacy.

4. In response to a complaint filed with the Department, a staff pharmacist stated that she always counsels patients on new prescriptions and that pharmacy technicians always ask patients if they have any questions for the pharmacist, whether or not the prescription is new.

5. On February 4, 2020, Respondent stated, "I consult on all new prescriptions and antibiotics. When the label states "new drug", I always speak to the patient about the medication. If the prescription is a refill, I allow the technician to ask the customer if there are any questions on the medication, but always listen to the technician asking this. If the patient seems uncertain, I go over and personally ask if the patient has any questions concerning their medication."

6. On February 7, 2020, the pharmacist confirmed this statement saying, "For all new prescriptions, I always counsel patients to ensure they know how to properly take their medications."

7. An offer for consult with a pharmacist does not satisfy Wis. Admin. Code § Phar 7.01(1)(e).

8. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

1. The Wisconsin Pharmacy Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 450.10(1), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. Pursuant to Wis. Stat. § 450.09, Stacey L. McDonald, R.Ph., as pharmacy manager, shall be responsible for the professional operations of the pharmacy.

3. By the conduct described in the Findings of Fact, Stacey L. McDonald, R.Ph., engaged in unprofessional conduct as defined by Wis. Admin. Code § Phar 7.01(1)(e), by failing to give the patient or agent appropriate consultation relative to the prescription; applying to original and renewal prescription orders. The consultation requirement applies to original and renewal prescription orders and is not satisfied by only offering to provide consultation.

4. As a result of the above violations, Stacey L. McDonald, R.Ph., is subject to discipline pursuant to Wis. Stat. § 450.10(1)(b)(1).

#### ORDER

1. The attached Stipulation is accepted.

2. Respondent Stacey L. McDonald, R.Ph., is REPRIMANDED.

3. Within ninety (90) days from the date of this Order, Stacey L. McDonald, R.Ph., shall pay COSTS of this matter in the amount of \$516.00.

4. Payment of costs (made payable to the Wisconsin Department of Safety and Professional Services) shall be sent by Respondent to the Department Monitor at the address below:

5. In the event that Respondent violates any term of this Order, Respondent's license (no. 16488-40) to practice pharmacy in the state of Wisconsin may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of the Order. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.

6. This Order is effective on the date of its signing.

Respondent Stacey L. McDonald, R.Ph., and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.
2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:
  - the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
  - the right to confront and cross-examine the witnesses against Respondent;
  - the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
  - the right to testify on Respondent's own behalf;
  - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
  - the right to petition for rehearing; and
  - all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.
4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Pharmacy Examining (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.
5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division

of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.

7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
