Margaret Summerside (Applicant), voluntarily and knowingly agrees to the issuance of a LIMITED license for the SOLE PURPOSE of completing a Board-approved nurse refresher course (Refresher Course), pursuant to Wis. Stat. § 440.08(3)(b) and Wis. Admin. Code §§ SPS 4.10 and N 2.40(3)(d)2.

NOW, THEREFORE, IT IS ORDERED that Applicant is GRANTED a LIMITED license for the SOLE PURPOSE of completion of a Refresher Course.

IT IS FURTHER ORDERED that pursuant to the Enhanced Nurse Licensure Compact, this LIMITED license for the SOLE PURPOSE of enabling the Applicant to complete the Refresher Course is limited to Wisconsin during the duration of this limitation.

IT IS FURTHER ORDERED that the LIMITED license shall be valid for a period of one (1) year from the date of this Order. If the refresher course is not completed within one (1) year from the date of this Order, the LIMITED license will expire, and the Applicant will need to reapply for a LIMITED license to complete the course.

IT IS FURTHER ORDERED that upon successful completion of the Refresher Course the Applicant will receive full licensure once all other requirements are met.

I, Margaret E. Summerside, have applied to renew my Wisconsin license to practice as a Registered Nurse. I have not been employed in a position which requires a Registered Nurse license within five (5) years since the date of my application for licensure. Therefore, I request a LIMITED license pursuant to Wis. Admin. Code § N 2.40(3)(d)2. to enable me to complete a Board-approved nursing refresher course (Refresher Course).

I understand that the LIMITED license will be for the SOLE PURPOSE of enabling me to complete the Refresher Course and that I am not permitted to use the LIMITED license granted herein to engage in any employment as a Registered Nurse.

I understand that pursuant to Enhanced Nurse Licensure Compact, this LIMITED license for the SOLE PURPOSE of enabling me to complete the Refresher Course is limited to Wisconsin during the duration of this limitation.

The LIMITED license shall be valid for ONE (1) YEAR from the date of issuance. Upon successful completion of the Refresher Course, I understand that I may petition the board for issuance of a full license by submitting documentation demonstrating completion of the Refresher Course. If the Refresher Course is not completed within this timeframe, I must reapply for a LIMITED license.
