On August 15, 2007, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice as a physician assistant for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On February 17, 2021, the Board considered Respondent's request for the return of full, unrestricted licensure. Based upon the information of record, the Board finds and makes the following:

<u>ORDER</u>

1. Respondent's license to practice as a physician assistant (license no. 748-23) is hereby returned to full, unrestricted status.

2. All limitations and encumbrances upon Respondent's credential are hereby removed.
