On May 6, 2010, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license (#130654-30) for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On January 14, 2021, the Board considered Respondent's request for the return of full, unrestricted licensure or termination of the hair test and/or a reduction in screens. Based upon the information of record, the following is entered:

ORDER

1. Respondent's professional nursing license (#130654-30) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
3. This order is effective the date of its signing.
