On July 8, 2016, the Wisconsin Board of Nursing issued an Order Granting Limited License ("Order") which granted Applicant a limited professional nursing license with certain terms and conditions. Pursuant to the Order, Applicant's license may be suspended, without hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Applicant is in violation of the Order. As a result, the following is entered.

ORDER

1. Applicant's professional nursing license (#170387-30) is hereby SUSPENDED until further notice.
2. Applicant may petition the Board or its designee for termination of suspension upon demonstrating continuous compliance with the terms and conditions of the Order for at least the most recent thirty (30) days.
3. This order is effective the date of its signing.
