On March 9, 2017, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license (#144219-30) and advanced practice nurse prescriber certificate (#3769-33) for an indefinite period. Respondent has been granted a stay of suspension and her license and certificate are currently limited with certain terms and conditions.

Information has been received that demonstrates Respondent is in violation of the terms of the Order and, as a result, the following is entered:

## **ORDER**

- 1. The stay of suspension is removed, and Respondent's professional nursing license (#144219-30) and advanced practice nurse prescriber certificate (#3769-33) are hereby SUSPENDED until further notice.
