On April 13, 2017, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s practical nursing license with certain terms and conditions.

On October 14, 2021, the Board considered Respondent’s request for removal of the limitations and the return of her license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent’s request for the return of her practical nursing license (#315792-31) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Respondent’s credential are hereby removed.
