On February 16, 2018, the Wisconsin Real Estate Examining Board ("Board") issued an Order Granting Limited License ("Order") granting Applicant's renewal of his real estate broker license with certain terms and conditions.

On June 5, 2021, the Monitoring Liaison considered Applicant's request for removal of the following limitations: 1) prohibition from driving current or prospective clients or customers in a motor vehicle, 2) quarterly self-reports, and 3) reporting of changes in Real Estate employment, status, address, or telephone number within five (5) days. Based upon the information of record, the Monitoring Liaison finds and makes the following:

ORDER

1. Applicant's request for removal of the following limitations is hereby GRANTED: 1) prohibition from driving current or prospective clients or customers in a motor vehicle, 2) quarterly self-reports, and 3) reporting of changes in Real Estate employment, status, address, or telephone number within five (5) days.

2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
