On March 25, 2019, the Wisconsin Board of Nursing (“Board”) issued an Order Granting Limited License (“Order”), granting Applicant a limited professional nursing license (#116014-30) for the sole purpose of completing the nursing refresher course. Upon receipt of proof of successful completion of the refresher course, this limitation would be removed, and Applicant’s license would be limited and suspended for an indefinite period. Applicant submitted proof that she has completed the nursing refresher course on January 21, 2020 and her license was limited and suspended indefinitely. Applicant received an initial stay of suspension on April 9, 2020.

On April 8, 2021, the Board considered Applicant’s request for a reduction in the frequency of drug and alcohol screens and access to controlled substances. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Applicant’s request for a reduction in the frequency of screens is hereby GRANTED. Applicant’s frequency is reduced to not less than 28 per year and one (1) annual hair test.
2. Applicant’s request for access to controlled substances is hereby DENIED for insufficient time under the Order to demonstrate adequate compliance.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
