On June 13, 2019, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license with certain terms and conditions. Respondent was required to complete four (4) hours of education in medication errors and five (5) hours of education in documentation. In addition, Respondent was required to pay costs and to provide quarterly work reports pursuant to the terms of the Order.

On June 22, 2021, the Board Monitoring Liaison considered Respondent's request for full licensure. Based upon the information of records, the Board Monitoring Liaison finds and makes the following:

- 1. Respondent's professional nursing license (#125179-30) is returned to full, unrestricted status.
 - 2. All limitations and encumbrances upon Respondent's credential are removed.
