On September 17, 2019, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s registered nurse license to practice nursing in the state of Wisconsin with certain terms and conditions.

On October 14, 2021, the Board considered Respondent’s request for removal of the limitations and the return of her license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent’s request for the return of her registered nurse license (license number 169282-30) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Respondent’s credential are hereby removed.
3. This order is effective the date of its signing.
