On October 4, 2019, the Wisconsin Board of Nursing ("Board") issued an Order Granting Limited License ("Order") limiting Respondent's licensed practical nurse license with certain terms and conditions.

On October 14, 2021, the Board considered Respondent's request for reduction and/or termination of drug and alcohol screens. Based upon the information of record, the Board finds and makes the following:

#### <u>ORDER</u>

1. Respondent's request for a reduction in drug and alcohol screens is hereby GRANTED. Respondent's frequency is reduced to not less than thirty-six (36) urine screens per year.

2. Respondent's request for termination of drug and alcohol screens is hereby DENIED.

3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
