On November 11, 2019, the Wisconsin Board of Nursing ("Board") issued Applicant a limited practical nursing license in the state of Wisconsin (#324617-31). Pursuant to the Order Granting Limited License ("November 11, 2019 Order") issued on the same date, Applicant's license was limited with certain terms and conditions.

On March 18, 2020, the Board issued an Order Imposing Additional Limitations ("March 18, 2020 Order") that further limited Applicant's practical nursing license based on the results of a fitness to practice evaluation completed on January 23, 2020.

On February 11, 2021, the Board considered Applicant's request for a reduction in testing frequency, termination of treatment requirements, and access to controlled substances. Based upon the information of record, the Board finds and makes the following:

ORDER

- 1. Applicant's request for the termination of treatment requirements, as outlined in the March 18, 2020 Order, is hereby GRANTED.
- 2. Applicant's request for access to controlled substances is hereby GRANTED. The related requirement outlined section 4.a.x. of the November 11, 2019 Order is hereby terminated.
- 3. Applicant's request for a reduction in drug and alcohol testing frequency is hereby DENIED due to access to controlled substances being granted.
- 4. All other terms and conditions of the November 11, 2019 Order not otherwise modified remain in full force and effect.
 - 5. This order is effective the date of its signing.
