On January 15, 2020, the Wisconsin Medical Examining Board (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s license to practice medicine and surgery with certain terms and conditions.

On February 17, 2021, the Board considered Respondent’s request for removal of the limitations and the return of her license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent’s request for the return of her license to practice medicine and surgery (license number 55674-20) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Respondent’s credential are hereby removed.
3. This order is effective the date of its signing.
