On March 12, 2020, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's registered nurse license with certain terms and conditions, including participation in a drug monitoring program.

On August 12, 2021, the Board considered Respondent's request for access to controlled substances and termination/reduction in the frequency of drug and alcohol screens. Based upon the information of record, the Board finds and makes the following:

### <u>ORDER</u>

1. Respondent's request for access to controlled substances is hereby GRANTED.

2. Respondent's request for termination/reduction in the frequency of drug and alcohol screens is hereby DENIED.

3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
