On April 28, 2020, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") issued an Order Granting Limited license limiting Applicant's professional nursing license with certain terms and conditions.

On June 10, 2021, the Board considered Respondent's request for termination or reduction in drug screens and termination or reduction of work reports. Based upon the information of record, the Board finds and makes the following:

<u>ORDER</u>

1. Respondent's request for reduction in frequency of drug screens to fourteen (14) per year, plus one (1) annual hair test is hereby GRANTED.

2. Respondent's request for termination or reduction of work reports is hereby DENIED. Insufficient time under the Board Order (April 28, 2020) to demonstrate adequate compliance.

3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

4. This order is effective the date of its signing.
