On June 11, 2020, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") requiring Respondent to complete four (4) hours of education in "documentation" and four (4) hours of education in "medication administration" within ninety (90) days. On September 28, 2021, Respondent's professional nursing license was suspended for failure to complete the education as ordered.

Based upon the information of record, which includes proof that Respondent has now completed the education, the following is entered:

### <u>ORDER</u>

1. The suspension of Respondent's professional nursing license (#199449-30) is terminated.

2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
