On July 9, 2020, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) limiting Respondent’s professional nursing license (#177821-30) with certain terms and conditions. Respondent was required to complete education on medication administration within 90 days, complete an Alcohol and Other Drugs (AODA) assessment within 90 days, complete a fitness-to-practice assessment within 90 days, and pay \$2,075.00 in costs of the proceeding within 120 days. The information of record demonstrates that Respondent has failed to complete the required education, assessments and pay the costs of the proceeding as ordered. As a result, the following is entered:

ORDER

1. Respondent’s professional nursing license (#177821-30) is hereby SUSPENDED.
2. The suspension shall remain in effect until Respondent has completed the required education, completed the required assessments, and paid the costs of the proceeding in full.
3. This order is effective the date of its signing.
