
On July 21, 2020, the Wisconsin Marriage and Family Therapist Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license to practice as a marriage and family therapist in training. Respondent was required to complete four (4) hours of education in documentation pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

ORDER

1. Respondent's license to practice as a marriage and family therapist in training (license number 593-228) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
