On August 5, 2020, the Wisconsin Board of Nursing issued an Order Granting Limited License ("Order") limiting Applicant's professional nurse license with certain terms and conditions. Pursuant to the Order, Applicant's license may be suspended, without hearing, for violation of any provision.
